Colebrook, Connecticut 2020 Declaration of Personal Property VEHICLE FORM

<u>Who Should File:</u> All owners of unregistered motor vehicles (e.g. campers, RV's, snowmobiles, trailers, trucks, passenger cars, tractors, off-road construction vehicles, etc.) including any vehicle garaged in Connecticut but registered in another state, or any such vehicle not registered at all. If you no longer own the personal property assessed in your name or moved the property out of Colebrook, you must provide the Assessor with a copy of the Bill of Sale, junk yard receipt or other documentation that the unregistered vehicle is no longer in your possession (all documentation must include the VIN #). If you do not, the Assessor must assume that you still own and have failed to declare your taxable personal property.

<u>Filing Requirement:</u> This declaration must be completed, signed and filed with the Assessor of the town where the personal property is located. Declarations of personal property shall be made annually. **Writing "SAME AS LAST YEAR" is not acceptable and will be considered incomplete.**

<u>Extension</u>: The Assessor may grant a filing extension for good cause (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing by November 2.

Penalty for late filing: Failure to file timely will result in a penalty equal to 25% of the assessment of the personal property. This declaration must be filed or postmarked (as defined in C.G.S. Sec 1-2a) no later than:
