New Business:

The department has evaluated battery operated hydraulic rescue tools from Genesis, TNT, and Hurst. We have received quotes from the vendors and the committee will meet on July 14, 2020 to make a final decision on what tools to purchase.

Steve Elovirta will remove the emergency lighting from Tanker 32. The plan at this time is to replace the lighting on Engine 2 with the lighting removed from the tanker.

Electrician Dave Hotchkiss was contacted and will figure out the problem with the light on the sign over the bays and give us a price on a new fixture that will light up the entire sign.

Captain Phelan was directed by the Chief, to research a different vendor to service the extinguishers. Captain Phelan will secure a new vendor from the sate bid list.

Rick Tillotson spoke to the homeowner on Beach Hill and they stated that they would have no issues with the department burning the structure. The department officers will formulate a plan of action regarding the burning of the structure.

Being no further business, a motion was made by Terry Phelan and seconded by Rick Tillotson to adjourn the meeting. The motion passed unanimously, and the meeting adjourned at 20:00 hours following the pledge of allegiance.
