Agenda Item 3. Agenda review

We moved **Agenda Item 6** to allow to the number three spot on the agenda. This allowed Mr. Chalder to address outstanding questions and concerns about the updated Zoning Regulations of May 4, 2021, Edition. Mrs. Neal moved to accept the Agenda adjustment and Mr. Fernandez seconded the motion. Discussion followed.

There were six items listed for discussion as presented by Mr. Buchanan. Mr. Chalder addressed all six questions/concerns to the satisfaction of the Commissioners. The discussion did not prompt any changes to the May 4, 2021, Zoning Regulations, Edition.

The Commission agreed to schedule a Public Hearing on the new regulations. Mr. Melanson agreed to submit the proposed regulations to the Northwest Hill Council Of Governments (NHCOG). The newly Proposed Zoning Regulations would need to be posted thirty-five days before a hearing/public meeting could convene.

Mr. Melanson also mentioned that food trucks at Norbrook Brewery, per the Governor's ruling, will no longer be permitted after May 19th. This the P & Z Commission can address this issue once the new P & Z Regulations are adapted/accepted.

Agenda Item 9. Bills and communications

We had a bill from Planimetrics and the town attorney. Nothing out of the ordinary.

Mr. Melanson recommended that the P & Z Commission retain the law firm of Halloran and Sage as our attorney of record for the foreseeable future. All agreed that this was a wise recommendation and accepted the suggestion.

Mr. Buchanan stated that if the State legislature passes an Affordable Housing Act the P & Z Commissioners would be obligated attend six to eight hours of training on the subject of administering Affordable Housing programs.
