Snack shack update ☐ Kim shared that last minute Food Handlers class was given by the Colebrook Community Center. In order to apply for temporary certificate, we need a certified Food Handler so she took the class which cost \$137. A motion to approve class reimbursement by Roxanne, Dave 2 nd . Motion APPROVED.
Summer events/ideas ☐ Soccer clinics: August 8, 15, 22 at 5:30-7 p.m Chris and Dan to run at CCS ☐ Archery- Kim inquired with Camp Jewell running a certification class which costs \$187. Dave found one online for \$69 with certification good for 3 years. Certification is valid for thousands of camps, schools and park districts worldwide and should be good for our Recreation program. Dan motioned for Dave and Kim to take online course for archery and to purchase equipment to run archery this summer. Katie 2 nd Motion APPROVED

All agreed that Recreation Board will run shack and serve burgers, hot dogs, pretzels, corn dogs, possibly chili, chips, candy and beverages.
New Business □ Soccer- Dan wanted to post registrations for fall soccer last Friday as area towns were accepting already. Kitty listed in newsletter and registrations sent home Friday. Decided to keep fees as is \$20 - Kindergarten, \$45- grades 1 & 2, \$50 − all upper grades; \$100 family maximum. Reviewing last year's numbers: Tentative: 3-5 K players, 7 for 1 & 2, 15 for 3 & 4, 15 for 5 & 6 and 16 for 7 & 8; Will update at August meeting. □ Colebrook Store billboard sign is very late. Jodi inquired about sign and asked for a deduction to rate this year. Dave motioned to approve reduction of initial cost to \$100 this year as sign late but will be out for Colebrook Fair. Chris 2 nd . Motion APPROVED. □ PTO billboard- Kim talked to Becky Roy who was unsure how sign originated as they are a non- profit group and cannot per guidelines donate to fundraising. Motion by Kim, 2 nd , by Katie to keep PTO sign up until the space is needed for another company ad. Motion APPROVED. □ New ideas: Katie mentioned a possible fish derby just for our town children. Board members figured since enough to do this summer, to keep this as an option during opening season in April. Talk about an obstacle course fun run as the color run was successful for PTO. Board members can discuss at August meeting for fall. □ Karate evaluations – Kim decided to excuse from meeting so Board could review. Roxanne will share results with her. There were many positive evaluations of Kim Janak and the karate program. Parents are pleased with the program and many commented how much the children
