- 1. The meeting was called to order at 2:05PM by Chairman Johnstone.
- 2. On a motion by Ben Bartlett to approve the minutes of the 10 February, 2022 meeting, seconded by Jim Millar, the minutes were approved. Three yes votes, one abstention (Andy Bakulski).
- 3. Review:
- A. Vehicle Asset Schedules The vehicle asset schedule was reviewed, Ben Bartlett noted that several of the assets listed for the fire Department need to be removed from the listing. He will update the list and Chris Johnstone will work with the Department of Public Works to make any necessary corrections on their part of the listing.
 - B. Status of current projects/year end closeouts the following projects were closed:

Jim Millar will update the Town of Colebrook 2021-22 Capital Improvement Plan to reflect the closed projects and the new balance of available funds.

C. Future Projects:

Selectman:

Bridge Projects: Jim Millar and Chris Johnstone discussed the Creamery Road and Sandy Brook Road bridge projects and reviewed the costs for these two projects. Jim Millar recommended that the Board of Selectman request a supplemental appropriation from the Board of Finance to cover the town's share of the cost for these two projects.

"Jim Millar moved that "the Board of Selectman request a supplemental appropriation of \$849,770 representing the town's remaining share of repairs to the Creamery Road and Sandy Brook bridges. The total cost of repairs is estimated at \$5.1 million, 80% of which will be reimbursed by the Federal Government. Repairs should be completed by the end of fiscal year 2023-24." Motion seconded by Chris Johnstone. There being no further discussion a vote was taken. Motion passed, Unanimous, 4 yes votes. Chris Johnstone will add this request for the supplemental appropriation to the agenda of the next Board of Selectman meeting.

Jim Millar also suggested establishing a "Line of Credit" (LOC) in the amount of \$500K at Iron Bank in the event of reimbursement delays and /or contingencies. Jim explained that it does not cost anything to establish the LOC unless we use it.

Chris Johnstone recommended to the committee members that they should consider adding funds to plan for replacement of the Senior Center bus. Will be discussed in depth at the next CIP meeting.

Chris Johnstone will develop new CIP meeting calendar for FY 23/24.

Board of Education:

Andy Bakulski discussed the projects that the Board of Education is considering for the Colebrook Consolidate School. In summary the projects include a new HVAC system, Air handling system and a water mitigation project to resolve the water intrusion problem affecting the boiler room. Andy explained that grant money will be available from the State of Connecticut and Eversource which will defray some of the cost of these projects. The actual cost of the projects and the level of funding from the grants is unknown at this time.

Fire Department:

Ben Bartlett discussed the future needs of the Fire House. Please see the attached document.

1-4 Year Plan

- 1. Colebrook Center Fire House roof needs to be reshingle and new gutters installed. Roof is 30 years old. Shingles are curling.
- 2. Colebrook Center Fire House Drain under tanker is caving in. Needs to be repaired or filled in by Town Crew or vendor.
- 3 Forge Fire Engine replacement for FY 2023. Truck will be 30 years old.
- 4. Colebrook Center FY 2024 Boiler replacement from oil to propane.
- 5. Hi-band radio replacement for fire apparatus and portable units, as the State is starting to switch over to the Hi-band. FY 2024
- 6. Forge Fire replace generator FY 2025. Old Detroit generator that has issues and the Fire House is used as an emergency shelter should be updated.
- 7. Apron (asphalt) at Forge Fire house to protect the concrete from cracking on entry & exit of the Fire house with the Fire trucks

- 8. Gear /Equipment replacement as was in past \$12K per year
- 9. First Responders Equipment, gear & supplies such as AED battery replacements and other vital equipment. \$5K per year
