### **Report of Committees:**

The Truck Committee: the new truck was approved by the town.

#### **New Business:**

Deputy Chief Hiller mentioned that there was an issue with a medic trying to cancel a recent call, although medics should not be canceling fire units. If that happens again, please try to be tactful and remind them that fire units should not be canceled by EMS.

The Colebrook Fair has asked us to do some sort of demonstration again. We may do another extrication. Chris Beaulieu asked if it is possible to use a minivan rather than another sedan.

We will be getting a repair estimate on the brush truck to see how much it would cost to keep that on the road.

For a well tank installation, Marc Melanson confirmed that we do not need a building permit. The tank is readily available, so this can move forward when ready.

The four gas meter's combustible sensor is not working. Captain Sartirana is checking whether this is under warranty. If not, he will order a new one. He would also like to make sure that we are calibrating these once a month.

Captain Sartirana made new forms for the SCBA's for monthly inspections of materials. There is a blue binder of these forms.

Maintenance nights will be held monthly on the first Monday of every month at 6:30 PM.

For anyone who needs fit testing, please go to the fire school at 6:30 PM on July 19<sup>th</sup>. Please coordinate with Captain Sartirana to make sure appropriate equipment is brought.

Evan Sartirana ordered a part to fix a radio. He will submit for reimbursement for \$15.

Captain Sartirana recommended that we get a new card to access Tractor Supply.

## **Chief's Report:**

Chief Bartlett shared appreciation for everyone who came to the Town Meeting to support the truck.

Canaan's Parade is on July 16 for anyone who would like to attend.

The Dinner Committee will meet on July 14.

The Camp Jewell fireworks will be the week of August 23.

Chief Bartlett requested a report from Terry Phelan for the fire at the church.
