Sealed bids endorsed "Replacement of Bridge No. 029003 Pinney Street over Mill Brook, Colebrook, Connecticut" will be received at the First Selectman's Office, 562 Colebrook Road, Colebrook, Connecticut until Wednesday, March 29, 2023, at 10:00 a.m. (EST) after which time no further bids will be accepted. NO EXCEPTIONS. Bids will be publicly opened and read in the Colebrook Town Hall Meeting Room (2nd Floor) at 10:30 a.m.

This project includes the replacement of an existing single span bridge carrying Pinney Street over Mill Brook (Bridge No. 029003) in Colebrook, CT. The project includes the full depth roadway reconstruction of approximately 195 linear feet of Pinney Street along with guide rail and slope protection improvements. The existing single span concrete cast-in-place slab structure will be replaced with a single span precast concrete rigid frame structure spanning over the existing abutments. The top portions of the existing masonry abutments will be removed and the remaining portions will be partially backfilled with rip rap and finished with a concrete cap.

This contract is subject to state contract compliance requirements, including nondiscrimination statues and set-aside requirements. State law requires a minimum of twenty-five (25%) percent of the state-funded portion of the contract for award to subcontractors holding current certification from the Connecticut Department of Administrative Services ("DAS") under the provisions of CONN. GEN. STAT. § 4a-60g. (25% of the work with DAS certified Small and Minority owned businesses and 25% of that work with DAS certified Minority, Women and/or disabled owned businesses.) The contractor must demonstrate good faith effort to meet the 25% set-aside goals.
