John Fernandez felt that the application was not sufficient. Traffic flow on the property was lacking. The drawing submitted is insufficient. Recommends follow up with DOT amid safety concerns.

Marty stated that the DOT concerns are left to the town to handle but the DOT 30' right of way should remain clear. Application does not provide right of way measurements on the drawing.

Jennifer LaRocque questioned if the Inland and Wetlands commission had approved this application. Martha Neal stated that the application has not yet been approved.
