The meeting was called to order at 6:04 p.m. by Chairman Wilber. Agenda items were reordered with discussion and finalization of the 2025-26 Town Budget happening first and then discussion and finalization of 2025-26 Capital Improvement Plan funding.

- 1. The discussion of the 2025-26 Town Budgets centered around securing figures within the Budget Worksheet. Several recommendations were made for changes to the worksheet in various lines.
 - a. Adjustments to revenue lines included:
 - i. an increase in the amount from prior year taxes, interest and fines,
 - ii. an increase in the amount on the motor vehicle supplement line
 - iii. an increase in the town operations income line,
 - iv. a change in interest income with the inclusion of an additional line, thus allowing the breakout of the figures to more accurately reflect sources.
 - b. Concluding adjustments to the worksheet categories, the target mill rate was discussed and resulted in a motion by T. McKeon, seconded by S. Norton, that: "The mill rate for the 2025-26 budget will be set at 33.7." Motion passed 4-2. (Yes: McKeon, Norton, Adams, Masslon. No: Wilber, Huften.)
- 2. The discussion on the 2025-26 Capital Improvement Program (CIP) funding occurred within the context of the Budget Worksheet discussion. Within that discussion it was determined that the transfer amount for 2025-26 CIP funding would be \$415,000.
- 3. Expense budgets for 2025-26 and the Capital Improvement Plan to be presented at the April 10, 2025, Board of Finance Colebrook Budget Hearing were discussed to finalize amounts and determine the next steps:
 - a. A motion was made by T. McKeon, seconded by S. Norton, to: "Present the Colebrook Board of Education Budget Proposal of \$2,254,241 at the Town of Colebrook Board of Finance public budget hearing on April 10, 2025." Motion passed 5-1. (Yes: McKeon, Norton, Wilber, Adams, Masslon. No: Huften.)
 - b. A motion was made by M. Masslon, seconded by K. Adams, to: "Present the Regional School District 7 Budget Proposal of \$2,398,702 at the Town of

- Colebrook Board of Finance public budget hearing on April 10, 2025." Motion passed 5-1. (Yes: Masslon, Adams, McKeon, Norton, Huften. No: Wilber.)
- c. A motion by S. Norton, seconded by T. McKeon, to: "Present the Board of Selectmen Budget Proposal of \$2,279,817 at the Town of Colebrook Board of Finance public budget hearing on April 10, 2025." Motion passed 4-2. (Yes: Norton, McKeon, Masslon, Adams. No: Wilber, Huften.)
- d. A motion by T. McKeon, seconded by S. Norton, to: "Present the Transfer to Capital Fund budget expenditure of \$415,000 at the Town of Colebrook Board of Finance public budget hearing on April 10, 2025." Motion passed unanimously.
- e. A motion by M. Masslon, seconded by K. Adams, to: "Include in the presentation budget an expense line item under "Other Expenditures" the amount of \$20,000 for Board of Finance legal expenses." Motion passed unanimously.
- f. A motion by M. Masslon, seconded by K. Adams, to: "Transfer the necessary amount of \$65,159 from the town surplus account to the general fund to balance the 2025-26 budget deficit as indicated on the Budget Planning Worksheet." Motion passed unanimously.
- 4. Other business resulted in a motion by T. McKeon, seconded by S. Norton, to: "Present the combined 2025-26 budget at the Board of Financed Colebrook Budget Hearing at 7:00 p.m. on April 10, 2025." Motion passed unanimously.
- T. McKeon moved to adjourn. Seconded by M. Masslon. Meeting adjourned at 7:47 p.m.
