

MINUTES OF ANNUAL TOWN MEETING OCTOBER 20, 2025

The meeting was called to order by First Selectman Bradley N. Bremer at 8:00 p.m. Nominations were opened for Moderator. Serena Brainard nominated Brad Bremer; she was seconded by Marty Neal. There being no other nominations from the floor and by hand vote Bradley N. Bremer was declared Moderator. The Moderator read the call of the meeting.

Item No. 1. The Moderator stated that there are two positions open and we will vote on them separately. The first position is currently held by Edward P. Catto, Ned would like to continue. The floor was opened for nominations. Kevin Robichaud nominated Edward (Ned) Catto; he was seconded by Marty Neal. There being no other nominations from the floor, and by hand vote, Edward P. Catto (U) was reappointed regular member of the Planning and Zoning Commission to serve a term of three years (October, 2025 to October, 2028).

The second position was vacated due to the retirement of Marty Neal. The Moderator thanked Marty for her years of service, The floor was opened for nominations. Marty Neal nominated Jen Hill; she was seconded by Hope Carfiro. There being no other nominations from the floor, and by hand vote, Jennifer D. Hill (U) was reappointed regular member of the Planning and Zoning Commission to serve a term of three years (October, 2025 to October, 2028).

Item No. 2. The Moderator stated that this position is currently held by Dave Goulet who is stepping down. The Moderator thanked Dave for his years of service. The floor was opened for nominations. Marty Neal nominated Kerry Jassen; she was seconded by Kevin Robichaud. There being no other nominations from the floor and by hand vote, Kerry R. Jassen (D) was appointed alternate member of the Planning and Zoning Commission to serve a term of three years (October, 2025 to October, 2028).

Item No. 3. The Moderator stated that the Zoning Board of Appeals has three regular member terms up for appointment and we will vote on one at a time. The first term is currently held by Tim Brainard, he wishes to continue. The floor was opened for nominations. Scott Salmon nominated Tim Brainard; he was seconded by Hope Carfiro. Being no other nominations and by hand vote, Timothy T. Brainard (R) was reappointed regular member of the Zoning Board of Appeals for a term of two years (October, 2025 to October, 2027).

The second position is currently held by Carol Sherwood, who has held this position for the past nineteen years. Carol wishes to continue. The floor was opened for nominations. for the second position. Serena Brainard nominated Carol Sherwood; she was seconded by Tim Brainard. Being no other nominations and by hand vote, Carol Ann Sherwood (R) was reappointed regular member of the Zoning Board of Appeals for a term of two years (October, 2025 to October, 2027).

The third position is currently held by John Fredsall who is stepping down. The Moderator thanked John for his years of service. The floor was opened for nominations. Tim Brainard nominated Scott Salmon; he was seconded by Kevin Robichaud. Being no other nominations and by hand vote, Scott R. Salmon (R) was appointed regular member of the Zoning Board of Appeals for a term of two years (October, 2025 to October, 2027).

Item No. 4. The Moderator stated this position is currently held by Cathie Norton who is stepping down. The Moderator thanked Cathie for her years of service and stated that Michael Corbin is interested in the position. The floor was opened for nominations. Cathie Norton nominated Michael Corbin; she was seconded by Scott Norton. Being no other nominations and by hand vote, Michael K. Corbin (D) was appointed alternate member of the Zoning Board of Appeals to serve a term of three years (October, 2025 to October, 2028).

Item No. 5. The Moderator stated that there are two positions open and we will vote on them separately. The first position is currently held by Mary Stauffer and she wishes to continue. The floor was opened for nominations. Scott Norton nominated Mary Stauffer; he was seconded by Scott Salmon. There being no other nominations from the floor and by hand vote, Mary H. Stauffer (U) was reappointed member of the Recreation Board to serve a term of three years (October, 2025 to October, 2028).

The second position is currently held by Katie Martin who stepping down. The Moderator thanked Katie for her years of service. Amy Salmon is interested in the position. The floor was opened for nominations. Scott Salmon nominated Amy Salmon; he was seconded by Scott Norton. There being no other nominations from the floor and by hand vote, Amy M. Salmon (U) was appointed member of the Recreation Board to serve a term of three years. (October, 2025 to October, 2028).

Item No. 6. The Moderator stated that this position is currently held by Becky Bodycoat and she wishes to continue. The floor was opened for nominations. Marty Neal nominated Becky Bodycoat; she was seconded by Kate Kennedy. There being no other nominations from the floor and by hand vote, Rebecca S. Bodycoat (D) was reappointed regular member of the Historic District Commission to serve a term of five years (October, 2025 to October, 2030).

Item No. 7. The Moderator stated this position is currently held by Dave Bishop who is stepping down. The Moderator thanked Dave for his years of service. Maureen Judge is interested in the position. The floor was opened for nominations. Scott Norton nominated Maureen Judge; he was seconded by Penny White. There being no other nominations from the floor and by hand vote Maureen E. Judge (D) was appointed alternate member of the Historic District Commission to serve a term of three years (October, 2025 to October, 2028).

There being no further business a motion was made by Marty Neal; she was seconded by Sherri Gray to adjourn the meeting at 8:07 p.m.
